

The Southeast Governmental Fleet Managers Association was established in 1993 and includes the states of South Carolina, North Carolina, Georgia, Florida, Tennessee, and Virginia.

This organization was founded in recognition of the need for fleet professionals to meet, discuss needs, and share information in order to promote more effective fleet management among governmental agencies.

SGFMA has an annual meeting and equipment show, offers free or minimal cost training throughout the year and provides scholarships to SGFMA members and/or immediate family.

SGFMA Mission Statement

- To foster and promote the advancement of the fleet profession through membership, association, and assistance to fellow fleet managers.
- To provide an open forum for the exchange of ideas, experience, and information related to the fleet management profession.
- To develop and promote improved standards and methods for the good management of fleet operations and assets.
- To seek the improvement of laws and regulations pertaining to fleet administration.
- Provide the exchange of information on procurement, maintenance, operation, and disposition of fleet equipment.
- Promote the professional, social, and personal interaction between members of the fleet management profession.
- To promote improved intergovernmental profession.



Applications are now open for the 2021 Leading Fleets award. The award is open to government fleets and recognizes operations that are performing at a high level in fleet innovation and leadership. **Applications are due May 19**.

Government Fleet magazine and the American Public Works Association (APWA) will name 50 Leading Fleets, with the top 20 being ranked. Additionally, winners will be announced for the No. 1 overall fleet, No. 1 small fleet (499 or fewer assets), No. 1 mid-size fleet (500-999 assets), and No. 1 large fleet (1,000 or more assets).

The recipients of these and other awards will be honored at the Government Fleet Expo & Conference during The Honors Celebration either in person or virtually. Winners will be featured in Government Fleet magazine's special awards issue.
